AFFIDAVIT OF ELIGIBILITY, WAIVER & RELEASE

The undersigned has been identified as a winner (the “Winner”) of the Plushie Giveaway (the “Giveaway”). The Winner represents and warrants that the below statements are true and agrees to the following:

1. Winner is *not* affiliated with Best Friends Animal Society (“BFAS”) as an employee or director of BFAS and is not an immediate family member (defined as spouse, parents, siblings or children as well as the spouses of the parents, siblings, or children) of an employee or director of BFAS.
