- **How do you propose to influence municipal animal services policies should you win the office you are seeking?**

The current code in West Jordan is working so I don't see the need for changes at this time. As for influencing other municipalities I plan to stay very involved with the ULCT and watch for state legislation that can effect West Jordan.

- **How much freedom do you believe that animal control facilities and shelters in Utah should have to implement new and different programs designed to save all healthy and treatable dogs and cats?**

As with all things a balance is needed, certainly the animal control officials have the most knowledge on what is the best practice. Without more context as to what those programs might be and the cost associated I don't feel I can fully answer this. I can say

that for me life of all living things is of value and should be considered in all decisions. I like most wish we had a country where all cats dogs and children that are born could be in a safe loving environment, sadly we aren't there yet.

- **Please describe what you believe are the top priorities of the animal shelter and field services in the city.**

Number one priority is to respond to resident concerns and to keep animals and humans safe. Education that is easy to access on what services are available is important as well as providing spay neuter and vaccine clinics.

The number one reason owners report surrendering their dog to a shelter, in Utah and nationwide, is housing barriers. Often these barriers are a lack of pet friendly rental housing and rental housing that has bans on certain breeds of dogs.

- **What can you do to help keep pets with their families and incentivize more pet-inclusive housing?**

As mayor in West Jordan city code is in the legislative branch. The one thought that comes to mind is perhaps with our good land lord program we could include something about animals. Ultimately a property owner has the right to decide within the law who they rent to.

If all pets were chipped reunification would certainly be sped up. Pet licensing could include chipping to help with this, also perhaps the police department could have chip readers for when animal services is closed. Owners also need to ensure they keep their contact information up to date.

General Background Questions

- **Please describe your experience with Best Friends or other animal organizations.**
I have been a pet owner all my life and love animals. As the owner of a comedy troupe and former theater owner, I have donated several tickets to Best Friends and other animal organizations for many, many years. I have also helped out at things like "Yappy Hour" since I also am a DJ with 103.1.
- **Do you have any pets? If so, what kind?**
Currently I have a British Lab, Aspen, and two cats, Fogo and CiCi. All three either rescued or adopted.
- **Why are you running for this office? What makes you qualified to serve?**
I'm running to help a city I love. I have spent many years on Arts Council's for West Jordan and Midvale and have run into a great deal of roadblocks from both city councils. I want to try to break that down and become more of a force for good in the city. In my life I have had management positions and I've always found people to see the

middle ground so that progress can be made. I live by the motto, "I Make Yes Happen!" That means when someone comes to me with a problem, I know that it is important to them and I will do what I can to help them. The "yes" might not be exactly what they were expecting/wanting, but I will find something that works for them.

I run for the city, not for Bob Bedore. If elected I know that it wasn't me that put me there and I will honor the trust that the people of the city put in me. It's not about my agenda, it's about the city's needs.

I haven't gone out for endorsements, other than a meeting I had with the board of realtors yesterday. I've been more focused on the individual voters. But I'm very new to all of this and I had better start acting like a politician and go after some.

- **What civic and/or professional organizations are you a member of?**

I don't believe that I'm a part of any organizations at the moment.

I have worked with the West Jordan and Midvale City Arts Councils. I have worked on the board of different theater groups in Utah - though I should say that "arts" aren't my only focus, it's just what I've done a lot of my life.

I've have continued to volunteer and mentor people where I can. My wife will tell you that I need to learn to say "no" from time to time, but that goes against my whole "Make Yes Happen" motto.

Issue Questions

- **How do you propose to influence municipal animal services policies should you win the office you are seeking?**

There are going to be a few things about working on a city council that will be new to me and I'll have to ramp up and learn. Some of the issues with animal services is a part of the things I need more education on. I can say that as an animal lover I will seek the best and most humane ways to help all animals. And I will be looking for much of that education and guidance from groups like yours.

- **How much freedom do you believe that animal control facilities and shelters in Utah should have to implement new and different programs designed to save all healthy and treatable dogs and cats?**

Obviously, saving the lives of the animals is very important. But I'm not sure what goes into the "how much freedom" part of your question. Just a very vague question.

- **Please describe what you believe are the top priorities of the animal shelter and field services in the city.**

I'd say that we seem to have a great deal of animals unregistered. Likely this is due to the cost involved. I believe that we can come up with a way to greatly reduce, or eliminate, the cost of registration on pets. The money can be made up on increasing the fees for those owners who have pets that cause a cost to our city - impound, etc.

Other than that, it's really about me learning the needs and problems associated with the pets of West Jordan so that I can better serve.

The number one reason owners report surrendering their dog to a shelter, in Utah and nationwide, is housing barriers. Often these barriers are a lack of pet friendly rental housing and rental housing that has bans on certain breeds of dogs.

- **What can you do to help keep pets with their families and incentivize more pet-inclusive housing?**

We can certainly look at what can be done with restrictions, but as much as I love animals, I find that the problems with pets is often in the owner over the pet. Owners who take on certain pets without a full knowledge of the requirements of that pet are doing a big disservice to the animal. This includes getting a breed of dog that might have a known history of being banned from certain residential properties. Taking on certain types of animals means that you're responsible for them. That could very well mean that you're going to have to find places that work for them. When I take on a pet I know that I need to be the one to find the ways to provide for them. I hope that doesn't come across as harsh, but I'm also a dog owner who had his dog attacked very viciously by another dog who broke away from his owner. It's the type of thing that has stuck with me. I don't blame that dog - I blame that owner.

- **70% of lost pets traveled less than one mile from their home. What steps can Utah take to ensure families get reunited and pets do not have to travel to the shelter?**

I think it's important to educate the owners of steps they can take. Make sure that your pet has very proper identification on their collars. I believe that with this it might be more possible to train others to return the animal to the owner instead of going to the shelter, but it is not going to always be that. If there is no answer, or no one is home, it wouldn't be good to leave the animal at the home. As an owner I'd feel better knowing that my pet was in a safe place rather than somewhere that they have already gotten out of.

Think about what would happen if a child got lost and didn't know how to tell someone where they lived. If the police picked them up, the child would go to some sort of police or welfare office until the parents can be located. This is the same for animals. You wouldn't just stick the child in the backyard and assume that the parent will be home soon.

So I'm not sure what can be done to completely fix the problem, but I'm always an advocate of educating the owner since I feel that most pet problems rest with the owner.

- **Please describe your position on trap-neuter-vaccinate-return (TNVR) programs by animal control facilities and shelters to humanely reduce the free-roaming stray cat population as provided by the Utah Community Cat Act.**

I would need to make sure that the program is run efficiently. The "vaccinate" portion of this and the examination of the animal to search for any possible diseases is a huge issue. While the Neuter-Return portion can help to reduce the population, having a disease spread within free-roaming population could be very harmful for the animals and humans. I'm good with the practice if it is handled fully and not just merely a fix then return policy.

I would also possibly look into having a period where the animal might be adopted before instantly being put back into the feral community, but I'm not sure of the numbers.

In short, the idea has some merit, but only if done fully.

- **Many cities across the country, and in Utah, provide funding for spay/neuter services, for the shelter and residents, in the city budget. Would you support city-funded support for spay/neuter procedures for dogs and cats in the city? Please explain.**

Certainly. I would support this issue, but would need to make sure that it works within the budget. I can see a policy where the animal can have the procedure and then if it is adopted a portion of the cost for that could be added to the adoption and returned to the city. I could also see exemptions for those who might not be able to afford the procedure. There are always middle grounds to explore, but the care of the animal is very important.

- **Do you agree that animal shelters should publicly share all inspection, intake and disposition data for the purpose of better lifesaving strategic planning and community engagement? Please explain your position.**

I'm always for transparency. But I do think that you're not looking at a bigger picture here. I'm for transparency in all businesses that deal with animals/pets. Pet stores should be completely transparent in where their animals come from. Anyone dealing with animals should be able to give a full accounting of their practices.

- **Would you support policies and ordinances to allow for the implementation of the necessary programs by animal control facilities and shelters that will save all healthy and treatable homeless dogs and cats?**

Don't require landlords to have anti-pet policies. Legislate how much landlords can charge for a pet fee/surcharge.
