



BY-LAW MODIFYING ZONING BY-LAW 720 IN ORDER TO PROHIBIT RETAIL SALE OF ANIMALS IN ALL ZONES

At the regular meeting of the City of Beaconsfield's Council, held at City Hall, 303 Beaconsfield Boulevard, Beaconsfield, Quebec, on Monday, December 21, 2015, at 8 p.m.;

WERE PRESENT: His Honour the Mayor Georges Bourelle and Councillors David Pelletier, Karen Messier, Wade Staddon, Pierre Demers, Roger Moss and Peggy Alexopoulos

WHEREAS a notice of motion of the present by-law was given at a regular Council meeting held on Tuesday, October 20, 2015;

WHEREAS a first Draft By-law 720-107 entitled "By-law modifying Zoning By-law 720 in order to prohibit retail sale of animals in all zones" was adopted at a regular Council meeting held on Tuesday, October 20, 2015;

WHEREAS a public consultation meeting regarding this by-law was held by Council on Monday, November 23, 2015;

WHEREAS a second Draft By-law 720-107 entitled "By-law modifying Zoning By-law 720 in order to prohibit retail sale of animals in all zones" was adopted at a regular Council meeting held on Monday, December 21, 2015;

CONSIDERING Section 113 of *An Act Respecting Land Use Planning and Development* (R.S.Q., Chapter A-19.1);

On motion given by Councillor K. Messier, seconded by Councillor P. Alexopoulos and UNANIMOUSLY RESOLVED:

THE COUNCIL OF THE CITY OF BEACONSFIELD ENACTS THE FOLLOWING:

SECTION 1: Article 4.2.2.1 entitled "Retail and Service Businesses (c1)" is amended as follows:

- a) By deleting paragraph "xiv. Pet store" of subparagraph b) of the first paragraph;
- b) By adding the following words at the end of paragraph "xv. Pet food and supplies" of subparagraph b) of the first paragraph: "without retail sale of animals";
- c) By adding the following words at the end of paragraph "xv. Animal grooming" of subparagraph d) of the first paragraph: "without retail sale of animals".

SECTION 2: Article 4.3 entitled "Prohibited usages in all zones" is amended by adding the following subsection g) after paragraph f):

"g) Retail sale of animals".

SECTION 3: This by-law shall come into force according to law.
