& 83-1. Definitions.

As used in this chapter 83-1et seq., the following terms shall have the meanings indicated:

ANIMAL CARE FACILITY- means an animal control center or animal shelter, maintained by or under contract with any state, county or municipality, whose mission and practice is, in whole, or in significant part, the rescue and placement of animals in permanent homes or rescue organizations.

ANIMAL RESCUE ORGANIZATION- means an individual or group of individuals who, with or without salary or compensation, house and care for homeless animals in the home of an individual or in other facilities, with the intent of placing the animals in responsible, more permanent homes as soon as possible.

OFFER FOR SALE- means to sell, offer for sale or adoption, advertise for the sale of, barter, auction, give away or otherwise dispose of a dog or cat.

& 83-31. Kennels and Pet Shops.

Any person, firm or corporation conducting, managing or operating any dog kennel or <u>pet shop</u> engaged in the business of boarding or housing dogs, within the limits of the Township of East Brunswick, shall pay for the privilege of maintaining, conducting or operating such kennel a license fee as established by N.J.R.S. 4:19-15.9. This license tax shall be in lieu of individual license taxes for such dogs.

& 83-31.1 Sale of Cats and Dogs in Kennels and Pet Shops, Exceptions

- A. A pet shop may offer for sale only those dogs and cats that the pet shop has obtained from or displays in cooperation with:
 - 1. An animal care facility; or
 - 2. An animal rescue organization.
- B. Nothing contained herein shall prohibit a shelter, pound or other establishment from keeping, displaying or selling any cat or dog which has been seized, rescued or donated.
